learning management system,

including instructional content, and host the platform for the Protected Species Workshop Licensure Program. As a certified Adobe Solution partner, HyerTek leveraged Adobe Captivate Prime LMS to transform the in-classroom learning solution into a Section 508/WCAG-compliant Web and mobile-based educational platform.

Platform tools and SharePoint Online integration, including Power Apps, Power Automate, and Power BI, in 2020.
